## Introduction

Needlebot, Inc. is a Princeton, New Jersey-based software-company that has developed a proprietary, patent-pending technology for dramatically improving Enterprise document search capabilities by abstracting the content of a document into a "mathematical fingerprint." The "mathematical fingerprint" of a document is much more easily understood and manipulated by computers than conventional language-based search approaches, allowing Needlebot to demonstrate superior search results and provide users with a new and attractive menu of search features, several of which were previously unavailable.

Two distinct test databases were used for the examples shown in this document.

- The **Reuters 1987 database** this contains 21,578 news articles from 1987.
- A subset of the **Reuters 1996 database** this contains 102,338 randomly selected news articles from the 800,000 available in the Reuters 1996 database.

The examples described in this document are intended to demonstrate the benefits of some of Needlebot's unique search features, described below, with a particular emphasis on our advanced **Similar Pages** tool which could be easily integrated into any existing Enterprise search engine to provide users with a unique and extremely powerful conceptual search capability.

Needlebot's advanced Similar Pages search tool has two distinct search capabilities:

- ➤ More like this with keywords
  - This option retrieves documents which contain the chosen keyword and are the most relevant to the selected document based upon their conceptual similarity and displays them in order of this relevance.
- ➤ More like this <u>without</u> keywords
  - This option retrieves documents which are the most relevant to the selected document based upon their conceptual similarity, whether or not they contain the selected keywords, and displays them in order of this relevance.

Needlebot's **Similar Pages** tool, based on content analysis, works much more effectively than other similar pages found in other online search engines, retrieving very relevant hits to the users' needs.

Needlebot's **User Profiles** search tool also provides a powerful search personalization technology that discerns an individual's interests and provide superior search results that are highly relevant to each user. Each user's profile evolves over time as interests in text retrieval change. In addition, multiple past profiles can be stored by the user and employed in future searches.

Finally, Needlebot's **Concept-based** search tool, (paragraph search tool), allows the user to search for concepts rather than keywords by pasting a paragraph as opposed to keywords into the search window. Results are then ordered based upon the level of overlap of their fingerprints when compared to that of the search paragraph. This unique approach, once fully developed, will avoid many of the limitations associated with current keyword-based search methods.



Commonly, users try several creative keyword combinations to retrieve results most relevant to their needs. This practice is obviously successful, yet can be very time consuming, particularly since some people appear to be more skilled than others in selecting the correct keywords to relay their needs to the search engine.

It is our intention, in the rest of this document, to demonstrate that these three features, implemented using Needlebot's patent-pending technology, provide a quantum leap to help users relay their intentions to the Search Engine and enable it to retrieve relevant hits very efficiently. We are also currently working on the implementation of other enhanced features that would provide a significant improvement in the user's enterprise and online search experience and also allow the delivery of highly targeted advertisements.

In most of the examples shown in this document, we usually focus on the top 5 search results returned for each query, partly because of space constraints but also because recent research\* indicates that the majority of search interactions occur within the first five hits. (The top hit alone accounts for over 40% of all search interactions and the top five hits combined account for 74% of all click-throughs).

SYDNEY, March 27 -<Northern Star Holdings Ltd> said Britain's <Associated Newspapers Holdings Plc> will hold 9.99 pct of its enlarged issued capital after applying to acquire 15.9 mln shares in its recently announced placement. Associated was one of the major investors participating in the previously reported placement of 128.9 mln shares at 3.75 dlrs each, Northern Star said in a statement. The northern New South Wales regional group is emerging as a national media force in the wake of the industry restructuring sparked by the News Corp Ltd <NCPA.S> takeover of the Herald and Weekly Times Ltd <HWTA.S> group. Associated now holds 3.3 pct of Northern Star's current issued capital, a company official said. As previously reported, Northern Star is raising 623 mln dlrs through placements and a subsequent one-for-four rights issue at 2.95 dlrs a share. Of the placements, 56.9 mln shares will go to a number of investors and 72 mln to investment group <Westfield Capital Corp Ltd>, which arranged Northern Star's purchase of News Corp's television assets, three newspapers and three radio stations for 842 mln dlrs. ## LONE STAR <LCE> SEES FLAT U.S. CEMENT DEMAND

GREENWICH, Conn., April 7 -Lone Star Industries Inc expects demand for cement om the U.S. to remain in the 85-90 mln ton range through 1992, its annual report said. The company said U.S. cement consumption totaled 90.6 mln tons last year, up four pct from 1985. **Note:** When an ambiguous keyword such as "star" is selected traditional keyword-based search engines typically display a mixture of relevant and irrelevant documents. Additionally, once a relevant result has been found, traditional search engines do not usually provide users with an efficient tool to find other highly relevant documents. The results given by similar pages tools offered by other search engines, such as Google, are often inadequate since they simply retrieve additional pages, (that happen to contain the original keyword), whether or not they actually contain the same topics as the selected hit. Needlebot's Similar Pages tool (with keywords) overcomes this problem by retrieving results based upon their conceptual similarity to the selected document. ## SHULTZ BEGINS ARMS TALKS WITH SHEVARDNADZE

MOSCOW, April 13 -U.S. Secretary of State George Shultz was holding several hours of talks with Soviet Foreign Minister Eduard Shevardnadze today in pursuit of the first superpower arms control agreement in nearly a decade. Shultz, accompanied by a panoply of senior advisers and technical experts, went directly into a closed-door meeting with Shevardnadze and the Soviet delegation after arriving in Moscow from Helsinki aboard a U.S. Air Force jet. State Department spokesman Charles Redman told reporters traveling with the secretary that as the crucial talks got under way, U.S. Arms control advisers were instructed not to discuss the substance of the American proposals with the press. It has been reported previously that some of the proposals - such as those dealing with President Ronald Reagan's "Star Wars" space shield against enemy missiles -- represent a hardening of the U.S. Position. Nevertheless, U.S. Officials have been optimistic about the possibility of progress on arms control during the talks, which are scheduled to end Wednesday. Reagan, who is believed to want an agreement before he leaves office in 1989, said last week that a breakthrough on an accord eliminating intermediaterange missiles (INF) in Europe was a distinct possibility. ## HOUSE COMMITTEE SLASHES "STAR WARS" FUNDING

WASHINGTON, April 7 -The House Armed Services Committee slashed President Reagan's funding request for the Strategic Defense Initiative (SDI), approving 1.7 billion dlrs less than he had proposed for the anti-missile program. The committee, during its consideration of the 1988 defense authorization bill, also cut by more than half Reagan's request for a rail system for strategic missiles. The proposals must be adopted by the full House and Senate before becoming law. The committee approved 3.5 billion dlrs for SDI, a land- and spacebased anti-missile defense program commonly known as "Star Wars." The amount was 1.7 billion dlrs less than the administration request of 5.2 billion dlrs. The Reagan administration has requested a total of 312 billion dlrs for defense in 1988, but congressional leaders have said that will be cut as part of a budget-trimming effort to reduce the huge federal deficit. In other action today, the committee approved 250 mln dlrs for a rail system for inter-continental ballistic missiles, but did not specify which missile system. Supporters have said





missiles on such a rail network would be less vulernable to attack than those in fixed underground silos. The administration requested 590 mln dlrs specifically for a rail-mobile system for the 10- warhead MX missile. But many congressmen, including House Armed Services Chairman Les Aspin, a Wisconsin Democrat, favor a smaller mobile missile dubbed the "Midgetman." Reuter more like this with or without keywords

### SENATE REPORT - REAGAN PLANS EARLY SDI DEPLOYMENT

WASHINGTON, April 7 -The Reagan administration is secretly developing plans for an early deployment of President Reagan's controversial "Star Wars" anti-missile system, according to a Senate study. "Near-term deployment is an absurd and dangerous course for America," said Sen. Bennett Johnston in a statement issued with the report. "It would force us to break the bank, throw out the ABM treaty and commit us to an arms race in space." The Reagan administration is engaged in an internal debate over the Strategic Defense Initiative (SDI), as the land and space-based anti-missile system is called, and may decide later this month to reinterpret the 1972 Anti-Ballistic Missile treaty to justify an acceleration of SDI research to include development and space testing. Johnston, of Louisiana, and fellow Democrat William Proxmire of Wisconsin, whose staff prepared the report, accused the administration of covertly seeking early deployment as a political ploy to commit the United States to strategic defenses even after Reagan leaves office in 1989. "This report exposes the fact that without a presidential directive or congressional consent, the SDI program ... is being changed to pursue a near-term deployment of strategic defenses," Proxmire, chairman of the powerful Senate Appropriations Defense Subcommittee, said. "In other words, they're covertly reorienting the SDI program without congressional approval." Reuter

**Note:** By simply applying **Needlebot's Similar Pages tool** (with keywords) to the hit at position #10 in the original results list, (see page 7), we were able to retrieve six highly relevant results, (five of which are shown above), related to the Star Wars project. This above example demonstrates how Needlebot's Similar Pages tool (with keywords) can help users to find multiple highly relevant results even when their original choice of keywords is not optimal.

**Needlebot's Similar Pages tool (without keywords)** can now be used to find additional highly relevant hits that are no longer restricted by the constraint that they must contain the keyword "star". In the next example, we will click on the *more the like this without keyword* link beneath hit #2, (see page 8), to retrieve additional highly relevant results that contain the same *topics* as this selected document. ## ISRAEL: Israel successfully test fires anti-missile missile.

JERUSALEM 1996-08-20Israel successfully test fired a U.S.-financed Arrow 2 anti-missile missile over the Mediterranean on Tuesday, officials said. They said the Arrow 2, launched from the coastline in central Israel, apparently hit its target which was fired four minutes earlier at about 3 p.m. (12 GMT) from a ship. Initial data indicates that the missile performed as planned, a Defence Ministry statement said. The results indicate that the Arrow's sensors locked in on the target, its warhead was activated and the target was hit. It was a big success said Moshe Keret, director-general of Israel Aircraft Industries in charge of the project. Keret said official confirmation as to whether the target was actually destroyed would take a few hours. Tuesday's flight was the third of the Arrow 2 but the first intercepting a missile. Keret said additional test launches would be carried out. Asked if the launch would allay Israeli fears after reports that Syria had recently test fired an advanced Scud-C missile capable of hitting Israeli cities, Keret told Israel army radio: Maybe not in the immediate future but when the system will be operational, maybe in about two years, that will certainly be an important and central layer in the defence system of the state of Israel. Tension has been rising between Israel and Syria over stalled Middle East peace talks since the May election of Likud leader Benjamin Netanyahu. Development of the Arrow was launched in the late 1980s and U.S. funding was approved as part of the Strategic Defence Intitiative, known as Star Wars. Most components of that initiative have since been scrapped but the 1991 Gulf War, in which Iraq fired dozens of Scud missiles at Israel, gave the Arrow new impetus with the United States ploughing nearly \$500 million for initial development. The project cost is estimated at \$1.2 billion, Israel spent several years developing and testing the Arrow 1 which it hoped would do a better job at hitting incoming missiles than the U.S. Patriot missiles, with a range of 10 km (six miles), deployed in Israel during the Gulf War. The target missile used in Tuesday's test-launch was a modified Arrow 1 missile with a radar cross section and payload to match that of a Scud missile, said the U.S. Army Program Executive Office Air and Missile Defence in a statement. The Arrow program is a joint U.S./Israel effort to develop an interceptor missile for the Arrow Weapons System. The information gained from the program has potential application for several U.S. missile defence programs, the statement said.

TEL AVIV 1996-09-12A successful test of the Arrow missile last month put Israel one step closer to developing a defence against enemy missiles, but its projected cost of only \$1.6 billion could be just a flight of fancy. Project officials say an operational version of the missile, funded jointly by Israel and the United States, will be ready in 1998, 10 years after the programme was launched. The budget estimate published by Israeli Defence Ministry would cover expenses through 2005 when Israel expects to field enough batteries to intercept missiles fired at any part of its territory. Getting to that stage of the project on \$1.6 billion is a ridiculous estimate. The Arrow will cost many times that figure, said Reuven Pedatzur, a political scientist who has researched the feasibility of the Arrow missile. The Arrow began as an adjunct of the U.S. Strategic Defence Initiative, or Star Wars, but took on a life of its own when Iraq fired dozens of Scud missiles at Israel in the 1991 Gulf War. The Iraqi missiles caused few casualties but the psychological effect on Israel's civilian population and the ineffectiveness of U.S. Patriot missiles in intercepting the Scuds made the missile defence project a top priority. The Arrow's radar system, developed by a subsidiary of Israel Aircraft Industry, is designed to track missiles fired at Israel and guide the Arrow, travelling at nearly three km (two miles) per second, to within four metres (13 ft) of an incoming missile. Somewhere between 10 km (six miles) and 40 km (25 miles) above the ground, the Arrow is supposed to intercept the incoming missile. Pedatzur, a reserve air force pilot who spent three years studying the Arrow project, said development and production of the radar, missiles and a command and control system that will coordinate the operations of multiple missile batteries would top \$6 billion. I don't know where he gets these figures. They are completely unfounded, said David Ivri, director-general of the Defence Ministry and a prime mover in the missile defence project. Ivri told Reuters Israel was spending roughly \$100 million a year on developing the Arrow, with \$40 million of that money coming from the United States. Security sources estimate the two countries have poured \$500 million into the project since 1991. Israel receives \$1.8 billion in annual U.S. military aid. An agreement between the two countries gives the United States access to the Arrow's research and development data. Ivri said the \$100 million a year would allow Israel to meet its 1998 target date for the current programme and subsequent projects. Israel, he said, would initially deploy two missile batteries to protect the populous central and northern regions of the country. Ivri would not say how



many missiles each battery would contain. The Defence Ministry published the \$1.6 billion estimate for the first time last month after years of media speculation, but it did not provide an itemised budget. Pedatzur said project officials deliberately undercalculated the cost. Had they given the real numbers, the people who make the decisions would have realised this project is impossible to finance. They want to ensure that the project continues, he told Reuters. Pedatzur compares the Arrow with Israel's illfated Lavi fighter plane. Israel spent \$1.5 billion on the Lavi programme before cancelling it in 1987 over speculation that development alone would reach \$2.6 billion. The number of Arrow missiles Israel will finally deploy is a key issue in the argument over budget estimates. According to Jane's defence magazine Israel would need more than 1,200 Arrows to defend against a combined Arab arsenal of 2,000 to 3,000 medium-range missiles. The price of each Arrow is expected to top \$2 million so that amassing a full arsenal alone would put Israel over the \$1.6 billion budget estimate for the whole Arrow programme. Pedatzur said the large difference between the cost of the Arrow missile and a Scud missile, estimated at \$500,000, would encourage Arab states to stockpile more and more missiles while Israel would be unable to match the pace. Project backers say in response that Israeli aircraft would destroy much of the Arab arsenal in a future conflict before the missiles are ever launched. Defence officials say Pedatzur is obsessed with disproving the Arrow's feasibility but he is not alone in questioning the feasibility of the programme. People on the inside, mainly from the air force, have raised some of the same questions he (Pedatzur) raises about the programme, said a retired senior officer who refused to be named. But as long as it appears that Arrow has a chance to succeed, no one on the inside is going to go public with the criticism, he said.

The phase one agreement specifies that all theatre missile defence systems with interceptor speeds up to three km (1.8 miles) per second are permitted under the ABM treaty, unless they are tested against targets with speeds over five km (3.1 miles) per second or ranges greater than 3,500 km (2,175 miles), Davis told reporters. She said the Patriot system, used against Iraqi Scud missiles in the Gulf War, its successor system and other lower-speed systems the nited States has under development had all been determined to be compliant with the ABM treaty. Christopher told a joint news conference with Primakov: This important progress assures that we can effectively defend against theatre ballistic missiles, while ensuring the integrity of the ABM treaty. Primakov said that the successful conclusion of the second phase -- on higher speed systems -- undoubtedly can move ahead the process of ratification of the START-2 U.S.-Russian strategic missile treaty by the Russian parliament. Russian deputies have dragged their heels over START, which will radically reduce strategic arsenals and has been ratified by the U.S. Congress, partly out of concerns over possible U.S. violations of the ABM treaty. There was no sign of progress at the Christopher-Primakov talks on the thorny issue of NATO expansion. Primakov said there were still different approaches to the question. NATO wants to name at a summit next year the first former Warsaw Pact countries to be admitted to the Western alliance. But Russia, despite some recent signs of flexibility, still objects to NATO's borders being moved up to its own. State Department spokesman Nicholas Burns indicated that the two countries continued to disagree over Iraq. Moscow sharply criticized U.S. missile strikes on Iraq this month after Baghdad's forces entered Westernprotected northern Iraq. Primakov did reiterate the Russian position against unilateral actions, Burns said. Christopher said he had asked Primakov to convey his and Clinton's concern for the health of Yeltsin, who has admitted he needs heart surgery. But Burns said U.S. officials learned nothing new about the Russian president's condition.

**Note:** The top four hits in the results list produced by **Needlebot's Conceptual Search tool** (paragraph search tool), are highly relevant documents related to the 1996 IRA bombing in Lisburn. The next few hits on the first page of the results list contained documents related to other 1996 IRA incidents including the 1996 London dockland bombing.

Note that the conceptual search paragraph used in this example, (see page 20), did not contain many of the keywords usually associated with these incidents such as: "IRA", "Irish Republican Army", "Protestant Loyalist gunmen", or "Sinn Fein".

The above example demonstrates the power of Needlebot's conceptual search technology to allow the user to find highly relevant documents without having to spend time thinking about what the ideal keywords should be for that particular search, (as is usually the case with traditional keyword-based search engines).

Furthermore, with traditional keyword-based search tools, even when the user has provided the correct keywords, highly relevant documents that contain synonyms of these specific chosen keywords are often missed completely. The above example demonstrates that Needlebot's conceptual search technology does not suffer from this limitation.

The cabinet backed the proposal in July, at its first meeting after the June 30 withdrawal of former president F.W. de Klerk's Calvinist National Party (NP) from President Nelson Mandela's unity government. De Klerk has listed opposition to abortion and a campaign for a return to capital punishment amongst key issues for his party, in opposition for the first time in nearly five decades. We want the people to feel that they have made their input and have been taken on board, he told a news conference. We are going to produce, as a result of these hearings, the thinking of the people. South Africa's Medical Research Council says close to 50,000 women report to hospitals every year after botched backstreet abortions from which over 400 die. About 1,000 abortions are approved every year for rape victims or women whose health is seriously threatened by pregnancy, but unofficial estimates are that about 120,000 women procure illegal abortions every year. Nkomo said the government would not consider a referendum to test public opinion and said the ruling African National Congress had not yet decided whether to join other parties and allow members a free vote. National Party health spokesman Willie Odendaal said his white-led Calvinist party would do everything in its power to reverse the move towards legal abortion on demand. The NP believes that both pre-born and post-born South African citizens have the same constitutional basic human right to life, he said. The Termination of Pregnancy Bill tabled by Health Minister Nkosazana Zuma this week plans free abortion on demand up to 12 week into pregnancy and under broadly defined conditions for a further eight weeks.

USA: Kevorkian supporters applaud Supreme Court decision.

DETROIT 1996-10-01Advocates on both sides of the assisted-suicide debate in Dr. Jack Kevorkian's home state applauded Tuesday the Supreme Court's decision to hear arguments on the controversial practice. But Geoffrey Fieger, attorney for the country's best-known assisted-suicide crusader, does not think the nation's high court will rule in favour of the right-to-diemovement. Fieger told reporters Tuesday he is concerned that conservative members of the nation's high court may use the opportunity to thwart Kevorkian's efforts. It would have been better if the Supreme Court did not hear this issue, said Fieger. Opening the way for a landmark decision, the high court said Tuesday it will review laws in New York and Washington states that ban a mentally competent, terminally ill person from dying with a doctor's help. The cases do not involve Kevorkian. The retired pathologist, who lives in the Detroit suburb of West Bloomfield, has fanned the debate on a national scale by helping at least 41 people from across the country die since 1990. Janet Good, founder of the Hemlock Society of Michigan, a right-to-die advocacy group, said she is glad the Supreme Court has finally decided to take up the issue. It's about time. The people of this country in all the polls have said what they want, and Im confident the Supreme Court will follow the lower courts, said Good, Good, who has been at Kevorkian's side when he helped people die and is herself terminally ill with pancreatic cancer, said she is also happy that Kevorkian is not involved in the cases. This is an issue that goes beyond Kevorkian, she said. Kevorkian's arch rival, Oakland County, Michigan, Prosecutor Richard Thompson, said he welcomed the Supreme Court's decision. He expressed confidence the court will find there is no constitutional right for doctor-assisted suicide. It would drastically transform the physician-patient relationship, and change the medical profession from healers into killers, Thompson said in a statement. Thompson lost his primary bid for re-election last month, partly because of his two unsuccessful attempts to put Kevorkian behind bars. A total of three juries have acquitted Kevorkian on assisted-suicide charges relating to five deaths. American Medical Association Chair Dr. Nancy Dickey said in a statement she is pleased the Supreme Court will make a declaration on what she called a misguided and unethical practice. Another Kevorkian foe, Cardinal Adam Maida, Archbishop of Detroit, said he is concerned about what the court may rule. Our experience with Supreme Court rulings has shown us that the moral values of life and death are often ignored in the debate over legal precedents, he said in a statement. Diane Trombley, a spokeswoman for Right To Life-Lifespan of Metro Detroit, predicted the court's ruling will not settle the matter. She noted the controversy that still rages more than 20 years after the decision legalising abortion.

## USA: RU 486 pill could transform U.S. abortion debate.

WASHINGTON 1996-09-18A chemical compound discovered in a French laboratory more than a decade ago could transform the abortion debate in America, an issue so explosive and sensitive that it has caused fissures in American politics and murders at American clinics. The U.S. Food and Drug Administration on Wednesday deemed approvable mifepristone, better known as RU 486, the French abortion drug. That means the FDA believes it is safe and effective, but the non-profit Population Council must provide the FDA some more information on labeling and manufacturing, conditions that the Population Council said it expects to fulfill. However, some abortion rights activists have concerns about whether all the obstacles -- technical and especially financial -- can be overcome to get the drug swiftly to market given all the political overtones of the abortion debate. There's no manufacturer standing ready and able to make it available for American women next week, next month, or even, I believe, next year, said Janet Benshoof, president of the Center for Reproductive Law and Policy. If you've just found out you're pregnant -- start picking names. Yet both sides in the abortion debate that has raged in the courts, in state legislatures, in national political campaigns and in the clinics regard FDA approval as a watershed that will make it easier for women to get an abortion early in pregnancy. The 1973 Roe vs. Wade Supreme Court ruling protecting abortion rights has stood repeated legal challenges. But although abortion is legal throughout the United States, access is very uneven. In most big cities, abortion is available, although some states have imposed waiting periods or restrictions on minors. But in more than four out of five U.S. counties, no doctors perform abortions. Many medical students, including future obstetricians, do not learn how to do them. Clinics have been vandalized and bombed. Patients have been accosted and harassed. Doctors and clinic workers have been murdered. But a pill means a woman does not have to go to a clinic. Early in her pregnancy -- the Population Council is seeking approval for the drug through the seventh week -- she just has to go to the doctor's office and swallow some pills that will block a hormone essential to pregnancy. It is by no means as simple as taking an aspirin. The patient requires close medical supervision and may experience discomfort. In most cases she will require a return visit to the doctor's office a few days later to take a second drug to start contractions to expel the embryo. But no protesters lingering outside with posters and pamphlets can tell who is getting an abortion, and who is just going in to her doctor for a stomach ache or sore throat. I believe it will help reduce clinic violence, said Eleanor Smeal, president of the Feminist Majority. And we already know that many more doctors will be willing to administer mifepristone than do surgical abortions. Anti-abortion rights groups have fought hard against the drug, accusing President Bill Clinton and FDA commissioner David Kessler of politicizing the drug approval process to advance an abortion agenda. The Clinton administration helped negotiate the unusual arrangement in which a non-profit group, instead of the pharmaceutical maker, sponsored the drug before the FDA and coordinated the clinical trials. For us it doesn't really change anything --National Right to Life Committee works by educating people about abortion, said the anti-abortion group's spokeswoman Michele Arocha Allen. We are seeing yet another way to kill unborn children, this time by using their mothers as guinea pigs as well, she said, arguing that long-term effects of the drug have not been adequately studied. Other anti-abortion groups were more blunt. Pro-life activists around the world consider RU 486 to be the modern day equivalent to the Zyklon-B gas used by Hitler, Operation Rescue said in a statement.

## USA: U.S. Senate expected to sustain abortion bill veto.

WASHINGTON 1996-09-25The Senate was expected to sustain President Bill Clinton's veto of the so-called partial birth abortion bill on Thursday, amid signs abortion rights supporters are increasingly edgy about the emotional issue. Both Democrats and Republicans said on Wednesday they expected the Senate to uphold Clinton's veto, although a handful of lawmakers who initially voted against the bill may change position on the contentious election-year issue. The House of Representatives narrowly voted to override the veto last week. The bill passed the Senate 54-44 in December, well short of the two-thirds majority needed for a veto override. Senate Majority Leader Trent Lott called the vote an uphill battle, but added it could get to be a lot closer than people thought as lawmakers switched sides. Partial birth abortion, technically called dilation and evacuation, is sometimes used in laterterm abortions. Under the technique a foetus is partially delivered feet first until just the head remains in the birth canal. The brains are then suctioned out and the skull collapsed. The legislation -- the first time Congress has moved to ban a specific abortion technique -- represents a turning point in the abortion debate from generalities to a graphic focus on the details of specific techniques. The emotional debate; intense opposition by the Catholic Church, which sent millions of postcards to Congress; and recent news articles showing it may be used more often than originally claimed, seem to be having an impact. Senate Minority Leader Tom Daschle, who voted against the original bill, said he had promised fellow Democrats he would try to work out a compromise measure after Thursday's vote. Daschle said he had no objection to banning the procedure for elective abortions where there was no health problem, but wanted to ensure it would be available when medically needed. We have no reservations about prohibiting the practice for purposes of just mere convenience, but we do believe that there are very vital, very important health issues that have to be addressed, said Daschle, a South Dakota Democrat. I have made a commitment ... to see if we can't work out language that would be suitable on all sides, and come back and pass this bill 100-0 next year, he said. Abortion opponents call the health exception a loophole to let the abortions continue and quote a coalition of physicians who contend there is no medical reason for the procedure. Further, they point to recent newspaper articles indicating the technique may be used more frequently than previously believed and in second-trimester abortions where there is no health problem with the woman or foetus. We aren't coming back next year and working out (any) compromise, said Andrea Sheldon, director of government affairs for the Traditional Values Coalition. Abortion rights groups initially estimated the technique was used about 500 times a year, mainly in cases of severe foetal abnormalities. Many senators who voted against the ban in December are becoming uncomfortable as they see their rationale unravel, said Douglas Johnson of the National Right to Life Committee. When Clinton vetoed the bill in April, he said he had concerns about the procedure but could not sign it because it did not include constitutional protections for a woman's health. The National Abortion and Reproductive Rights Action League challenged news reports saying the total was higher. We're getting all caught up in the numbers ... and we're allowing the other side to distract us, said NARAL president Kate Michelman who called the bill an unprecedented intrusion into medical practice that would endanger women's health. According to the Alan Guttmacher Institute, nearly 90 percent of the 1.5 million U.S. abortions each year take place in the first 12 weeks of pregnancy.

### AUSTRALIA: Worlds first voluntary euthanasia law survives.

SYDNEY 1996-08-22The world's first voluntary euthanasia law survived a challenge in Australia's Northern Territory parliament on Thursday when opponents failed in a bid to repeal the assisted suicide legislation. The territory's parliament defeated the Right to Human Life bill 14 to 11 in a free vote after a five-hour debate. The law, which came into effect on July 1 but has not yet been used, survived a court challenge last month and still faces challenges in the national parliament and Australia's High Court. The assisted suicide law allows terminally-ill patients to end their life by lethal injection or pill as long as they meet strict conditions. Territory opposition backbencher Neil Bell, who introduced the right to life bill, said he was disappointed with the vote, but that the matter was far from resolved. There's a lot of people out there who are concerned and a lot of other people who don't understand it, Bell told Reuters by telephone from Darwin, the territory's capital. Doctors have been warned they may face murder charges if they assist a patient to die and the law is subsequently repealed. The territory's Supreme Court last month rejected a challenge brought by a coalition of doctors, church and aboriginal leaders, ruling the law was within the territorial parliament's power. The euthanasia law still faces a challenge in Australia's national parliament where a government backbencher intends to introduce legislation in the next few weeks to override the law. A challenge is also expected in Australia's High Court with euthanasia opponents seeking a ruling on the legislation's constitutional validity. Northern Territory Chief Minister Shane Stone said on Thursday he expected the challenge in the national parliament could succeed.

## FRANCE: Hunger strikers vow to maintain Paris protest.

PARIS 1996-08-23The 300 Africans holed up in a Paris church since June said on Friday they planned to maintain their occupation, following Prime Minister Alain Juppe's refusal to grant them blanket permission to remain in France. Spokeswoman Madjiguene Cisse, one of the 300 in the Saint-Bernard church, said the decision to keep up the protest had been urged by the 10 of them who are on the 50th day of a hunger strike to pressure the government into granting them all residence permits. The decision came after Juppe announced in a television message that France's highest administrative court, the Council of State, had endorsed his government's view that the 300 Africans were not legally entitled, as a block, to residence permits. But Juppe said the government still intended to review their right to remain in France on a case-by-case basis and had no intention of using deportation to break up families or expel seriously ill individuals. Following Juppe's videotaped statement, protesters said they had received several calls warning that police were preparing to eject them early on Friday, although hundreds of sympathisers have surrounded the Saint-Bernard church to protect them. Juppe said the Council of State fully backed his view that the group of protesting immigrants lacked the right to stay in France under 1993 laws tightening conditions for residence. It would be against the law to give blanket residence permits to this or that group. We are going to continue a review of individual situations, he said. However he added: It never crossed our mind to expel someone who is seriously ill, separate a mother from



her children, break up a couple, or expel parents of children who were born in France or are French citizens. In a possible face-saving way out of their impasse, Cisse, in an interview with Reuters, hinted that the 10 hunger strikers might end their fast should the government give them a written guarantee that they were entitled to residence permits because their refusal to eat had left them seriously ill. Many of the protesters say they once had residence rights and were plunged into illegality by hardline 1993 laws pushed through by theninterior minister Charles Pasqua at a time of mounting anti-immigrant sentiment. Lawyers say loopholes in the laws, which also tightened conditions for citizenship, have created a legal nightmare. Juppe said the law would nonetheless be enforced. But the farright National Front party, which advocates sending home all immigrants, taunted Juppe for weakness. Words yes, but where is the action? a Front statement said. Signalling their determination to force the government into what would amount to a humiliating retreat, the protesters have called a new rally for next week after a march through Paris drew 5,000 demonstrators on Wednesday. The hunger strikers have been drinking sweet tea and taking vitamin pills, but two are said to be in a serious condition.

It is interesting to note that most of the results listed above are clearly related by the fact that they contain the same general theme: i.e. *laws governing the right to end a life* – a topic that is clearly included in the original target search paragraph.

The above example demonstrates the power of Needlebot's conceptual search technology to go beyond the realm of simple keyword-based searches and instead, give the user the option of finding documents that may span different topics but contain the same general themes.

USA: U.S. High Court denies Unabomber suspects appeal.

WASHINGTON 1996-10-07The Supreme Court Monday rejected an appeal by accused Unabomber Theodore Kaczynski seeking to prevent the Justice Department from prosecuting him because of government leaks to the news media. Kaczynski, who has been charged in a number of the mail bombings attributed to the so-called Unabomber because universities and airlines were the first targets, also asked the justices to order a lower-court hearing to go over the evidence supporting his claims. But without comment or dissent, the high court denied the appeal by the former mathematics professor turned recluse who was arrested in April at his remote Montana cabin. In his Supreme Court appeal, Kaczynski claimed the leaks poisoned the entire population of grand jurors within the United States against him. A Justice Department prosecutor told a court hearing in California last month that Kaczynski, 54, kept detailed journals in which he admitted each of the 16 bombings since 1978 that killed three people and injured 23 others. On June 18, a federal grand jury in Sacramento, California returned a 10-count indictment against Kaczynski charging him with four separate bomb attacks that killed two persons and injured two others. Kaczynski has pleaded not guilty to those charges, which carry a maximum sentence of the death penalty. Later in June, the Justice Department announced that four new indictments had been unsealed charging Kaczynski in three more bombings in Utah, Tennessee and Michigan in the 1980s. In October, Kaczynski was charged with the 1994 mail bomb attack that killed advertising executive Thomas Mosser at his home in New Jersey. Justice Department prosecutors plan to go forward first with the Sacramento case, although a trial date has yet to be set. Kaczynski remains in jail without bond. The Supreme Court's rejection of Kaczynski's appeal marked the third time he has lost on those arguments. U.S. District Judge Charles Lovell in Montana had rejected Kaczynski's claims that his chances of setting a fair trial had been hurt by the spate of government leaks to the media during the search of his cabin. Then a federal appeals court in California denied Kaczynski's appeal. The Justice Department urged the Supreme Court to turn down the appeal, saying review was not warranted on procedural and substantive grounds. Department lawyers said Kaczynski's claims lacked merit and added that he cannot establish that he was prejudiced by the disclosures. They said Kaczynski's requested remedy would be too drastic, barring all prosecution against him. Among the items found in Kaczynski's cabin were an original copy of the Unabomber's rambling anti-technology manifesto, a typewriter used to write it, a bomb, a partially completed bomb and bomb making parts, FBI officials have said. more like this with or without keywords add to profile CRIME

NEW YORK 1996-09-11The family of alleged Unabomber Theodore Kaczynski was so concerned about his mental state in 1991 that they tried to get him committed to a mental hospital, his brother and sister-in-law said in their first television interview. In the interview to be aired on Sunday on CBS's 60 Minutes, David Kaczynski, who turned his brother in to the FBI in April, said he and his wife, Linda Patrik, failed because it is extremely difficult to have someone committed. The couple added they knew nothing at the time about a link between Theodore Kaczynski and the Unabomber, who in a 17-year letter bombing campaign killed three people and injured 23 others in a self-declared war against technology. Patrik said she and her husband went to a pyschiatrist who advised us that Ted was mentally disturbed, seriously disturbed -- that not only was he disturbed but that there was the possibility of violence. That stuck in my mind and it's stuck in my mind all these years. She said they were also told it was very difficult to have someone committed. so we did the next best thing that we could think of. They contacted one of Theodore Kaczynski's doctors in Montana, where he lived in a remote cabin, and asked the doctor to refer to therapy. We were told he had to be a danger – a demonstrable danger to himself or others to have him committed, David Kaczynski said. He said he became suspicious about his brother early this year after newspapers published a 35,000-word anti-technology manifesto from the Unabomber. In it, he spotted many of his brother's ideas. Also interviewed on the programme was the Kaczynskis mother Wanda, who said the family would not profit from the \$1 million reward offered for the Unabomber's capture. We are not going to profit one cent from that, she said.

### USA: U.S. wants prompt start to Kaczynski trial.

SACRAMENTO Calif. 1996-09-14The U.S. government wants the trial of Unabomber suspect Theodore Kaczynski to begin at the end of March next year, according to court documents. In papers filed in U.S. District Court in Sacramento on Friday, federal prosecutors proposed that all pre-trial motions in the complex case be filed by November 20 and asked that the trial itself should begin on March 31. 1997. Prosecutors said it was especially important that any defence arguments about Kaczynski's sanity or competence to stand trial be raised early enough to avoid delay to the trial caused by psychiatric evaluations and related hearings. The defence has not said if it will raise such arguments. The timetable will be discussed at the next hearing in the case, set for September 20 in the California state capital before U.S. District Judge Garland Burrell. The defence response to the government's proposed timetable was not immediately known, but defence attorney Quin Denvir said in June he thought it very unlikely the trial would start in less than a year because defence attorneys have to go through a mountain of evidence turned over by the government. Kaczynski, 54, a Harvard-educated former mathematics professor turned mountain hermit, is accused of being the shadowy Unabomber who killed three people and injured 23 during an antitechnology bombing campaign between 1978 and 1995. Kaczynski was arrested at his remote cabin in Montana in April and was transferred two months later to Sacramento where he has been charged with four of the bombings, two of them deadly. He has pleaded not guilty. In a status report on the case, prosecutors said they had turned over extensive evidence to defence attorneys. By law, prosecutors are required to share the evidence they have with the defence before trial. Prosecutors said they had turned over evidence relating to not only the four bombings that Kaczynski is charged with but also 13 additional bombings and other actions with which he has not been charged. Prosecutors said in the court papers that evidence found in Kaczynski's Montana cabin inluded a fully functional bomb. The government said investigators had opened more than 2,000 files on people who were investigated during the 17-year Unabomber probe, one of the most intensive in FBI history. Voicing concern about the privacy of innocent people who were investigated, prosecutors proposed strict conditions on sharing this information with the defence to prevent the names of those investigated from being made public. Prosecutors disclosed that they have asked that Kaczynski voluntarily provide handwriting, hair and blood samples, saying the samples were needed to complete the forensic review of certain physical and documentary evidence. If the government and defence could not agree on providing the samples, prosecutors said they expected to file a court motion to try to force Kaczynski to provide the samples. The federal charges against Kaczynski can carry the death penalty, although the government has not yet said if it will seek the death penalty against him. Kaczynski is held in an isolation cell at the Sacramento County jail.

## USA: Supreme Court opens term denies Kaczynski appeal.

WASHINGTON 1996-10-07The U.S. Supreme Court opened its new term on Monday, denying Unabomber suspect Theodore Kaczynski's request that his case be thrown out and rejecting a challenge to the Whitewater special prosecutor's authority. Reviewing a wide range of controversies, the high court also rejected a challenge to a 1994 federal law that guarantees access to abortion clinics and declined to take up sex-harassment cases involving schools and the workplace. The nine justices returned to the bench after a three-month recess, hearing oral arguments in three important cases while also disposing of most of the 1,600 appeals that piled up during the summer. The court got an early start to its 1996-97 term last week by entering the nationwide right-to-die debate and agreeing to decide if mentally competent, terminally ill patients may seek help from their doctors to commit suicide. On Monday it issued more orders, but did not add to the cases it has already agreed to decide during its new term. In perhaps the most widely publicised case, the high court rejected arguments by Kaczynski, the former mathematics professor turned recluse, seeking to bar his prosecution because of government leaks to the news media, Kaczynski, 54, allegedly carried out 16 mail bombings that killed three people and injured 23 since 1978. He had sought in his appeal a lower-court hearing to go over the evidence supporting his claims. Kaczynski, who is awaiting trial in California and has pleaded innocent, claimed the leaks poisoned (against me) the entire population of grand jurors within the United States. In another key case, the Supreme Court rejected appeals by former Arkansas Gov. Jim Guy Tucker and two business associates challenging Whitewater special prosecutor Kenneth Starr's authority to bring charges against them. The justices let stand a lower-court ruling that upheld Starr's jurisdiction to prosecute any offence he uncovers in his wide-ranging investigation of the failed Whitewater land deal in Arkansas, in which President Bill Clinton, then the state's governor, and his wife were partners in the 1980s. On the bench, the justices heard arguments on whether cable television companies can be forced to carry local broadcast stations -- a rule the cable industry has attacked as a form of illegal censorship. They also heard arguments in a case from Mississippi on whether a mother whose parental rights have been terminated may be required to pay more than \$2,000 in court costs before being allowed to appeal. In other action Monday, the court: --let stand a ruling that Congress has the power to adopt a 1994 law making it a crime to use force, threats of force or physical obstruction to inr interfere with abortion clinic staff or their patients; --rejected three separate appeals urging it to declare that the federal civil rights law covers sexual harassment in the workplace involving employees of the same sex; --turned down an appeal, supported by the Justice Department, seeking to hold schools liable under a federal law for failing to stop sexual harassment of female students by male students. more like this with or without keywords add to profile CRIME

## USA: Officers in King beating face no further prison time.

LOS ANGELES 1996-09-26A federal judge ruled Thursday that the two white policemen convicted in the videotaped 1991 beating of black motorist Rodney King will not be sent back to prison. Former Los Angeles police sergeant Stacey Koon and ex-officer Laurence Powell have been free from federal custody since December, but had to be formally resentenced to conform with a recent Supreme Court ruling in an appeal. The Supreme Court last June upheld the relatively lenient 30-month prison terms imposed by U.S. District Court Judge John Davies in 1993, but had ordered the judge to hold another hearing in case he wanted to reconsider the sentences. That was needed because the Supreme Court had set aside an appeals court ruling calling for Koon and Powell -- who were found guilty of violating King's civil rights



-- to receive more prison time. At Thursday's hearing, Davies reinstated his original sentence, allowing the men to remain free. Prosecutor Lawrence Middleton had sought more prison time plus fines, contending that the punishment they received was too light and that Koon had profited from his notoriety to the tune of close to \$10 million. We're satisfied, Koon's attorney, Ira Salzman, said outside court. But he accused prosecutors of meanness for making a last-ditch effort to impose further punishment. Koon, Powell and two other officers were acquitted of the beatings in state court in April 1992, touching off three days of rioting in Los Angeles that left 54 people dead and more than \$1 billion in damage. Koon and Powell were later convicted in a federal trial, while former officers Timothy Wind and Theodore Briseno were found not guilty. Under federal sentencing rules, Koon and Powell faced a potential sentence of 70 to 87 months, but Davies departed from the guidelines and imposed 30-month prison terms. Black community leaders denounced the sentence as far too lenient for the defendants roles in the videotaped attack, which was shown repeatedly on national television and sparked outrage against police brutality. Davies at the time cited several factors in justifying his downward departures from the sentencing guidelines, including his view that King had resisted arrest and was partly responsible for his own beating. Davies also said the officers were susceptible to abuse by others inmates in prison, that they had been subjected to state and federal prosecutions and that they had lost their jobs and livelihood. Acting on a request from prosecutors, a federal appeals court ruled that Davies should not have departed from the guidelines and, by implication, that the two should have drawn longer sentences. But the Supreme Court disagreed, ruling that most of the reasons Davies used to impose shorter prison terms were legally sound. In a final effort to change the judge's mind, Middleton said Thursday that the men should at least be fined. He contended that Koon had earned millions of dollars from sales of his book and contributions to a legal fund used to pay for his defence in three trials. King, who won \$3.8 million in damages from the city of Los Angeles and has continued having regular run-ins with the police, was not in court Thursday. But Koon and Powell sat behind their attorneys, showing no emotion when the judge announced his decision.
